# Cost information for the academic year 2025/2026

Collegium Augustinianum Gaesdonck is an episcopal boarding school run by the Collegium Augustinianum Gaesdonck Foundation. As a foundation under private law, the Collegium Augustinianum Gaesdonck finances its special educational offerings on campus and within the framework of the boarding school mainly from the contributions of parents and from foundation funds.

The costs and fees for boarding and day boarding services - including education, accommodation, incidental expenses and meals - are determined by the Gaesdonck Foundation Board for each academic year. The same applies to the costs for the (non-boarding) upper school external ("OEx").

Our grammar school is a substitute school of the state of North Rhine-Westphalia. Attendance at the school itself is therefore free of charge, but there are additional costs as at all comparable public schools (cultural contribution, etc.). Additional costs for meals are incurred in the upper school also for non-boarding students. Membership of the Gaesdonck Circle of Friends is expressly desired.

The contract period for a school year covers the period from 01 August to 31 July of the following year - irrespective of summer holidays or graduation. If several **siblings** attend Gaesdonck full boarding at the same time, the boarding school fee for the younger child is reduced by 20%. Children of Gaesdonck **alumni** receive a 3% discount on boarding school fees.

On conclusion of the boarding school contract, we charge a one-off admission fee to cover administrative costs.

The boarding school costs for international students are usually collected by us in advance for a full school year.

Please ensure that your child has comprehensive accident, liability and health insurance valid throughout Europe for the entire duration of his/her stay. If we do not have such proof, we will insure your child accordingly. In this case, an annual insurance premium as shown above will be charged. All pass-through costs will be settled exactly at the end of the stay. Any surplus will be refunded.

#### The small print:

- \* Calculation basis: 2-week rhythm outside holiday periods (alternation of boarding and home weekends)
- \*\* Calculation basis: permanent residence at Gaesdonck campus outside holiday periods (including home weekends)
- \*\*\* The boarding school fees for students whose main residence is in Germany or the EU are generally collected by us on a monthly base. The total annual fee for students outside the EU is due in advance of the respective school year on May 15<sup>th</sup>. Half-yearly payment is possible with a surcharge of 1.5% on the boarding school fees (due on May 15<sup>th</sup> and November 15<sup>th</sup>).
